

## **Terms & Conditions**

*These general conditions apply to promotional activities of Naviparking Holland B.V. .*

- 1. These conditions apply to promotional campaigns of Naviparking Holland B.V. hereinafter referred to as "the Organizer".*
- 2. The aim of the promotion is to award a number of prizes to a number of selected participants by means of the Naviparking APP installation and registration.*
- 3. In the context of this promotion, the Organizer will process the information provided by you in order to allow the presentation of the prizes and to send you a newsletter and future promotions if you have indicated that you want to receive a prize.*
- 4. The promotion runs from 1 november 2018 to 31 december 2018.*

### **II. Participation**

- 5. Participation in this promotion is open to everyone, with the exception of the persons mentioned below. Participation in the promotion is free and free of charge. There is no obligation for the participants with regard to participation.*
- 6. By participating in this promotion you agree to the terms and conditions.*
- 7. The Organizer and the participants are bound by the content and provisions of these conditions.*
- 8. Participation is excluded for persons not residing in the Netherlands or without residence in the Netherlands.*
- 9. Participation is excluded for people younger than 18.*
- 10. Employees of the Organizer are excluded from participation, as well as anyone who in any way is involved directly or indirectly in organizational sense in this action.*
- 11. The information required for participation shall be the property of the organizer and shall not be sold or distributed to third parties. The data is recorded in a database; the Personal Data Protection Act applies to this file. The data will be used to implement this action and for marketing activities.*

### **III. Way of play**

- 12. Participation in the promotion takes place by downloading and installing the Navi parking APP and registering personal data in the APP and a final confirmation by email.*
- 13. The winner will be chosen from the participants registered by the Organizer.*
- 14. The weekly winners will be notified by email. If a participant has won nothing, he / she will not receive a message from the Organizer.*
- 15. No correspondence can be made about the result.*
- 16. Participants may only participate once.*

### **IV. Prizes**

- 17. The weekly prize winner wins one tablet.*
- 18. The prizes are only handed to the winning participants and can not be exchanged or paid out in cash.*
- 19. There are 10 prizes to be won. From 1 November 2018 a Samsung Galaxy Tab S2 will be made available weekly. The prizes will be raffled among the registered users in the*

*Naviparking App. The prize winner will be informed personally by e-mail of the result. No correspondence can be exchanged about the result of the promotion and no rights can be derived from participation. The Organizer is not liable for damage resulting from or related to the use of the prize won. Each winner is responsible for paying any applicable taxes with regard to obtaining the prize. Prizes can not be exchanged for money. The Organizer is not responsible for computer and / or internet disruptions.
